Terms and Conditions of Participation in Conejo Valley Little League

Agreement to Participate

I/we the parent(s)/guardian(s) of the named applicant(s) hereby give my/our approval to participate in and all Little League activities. I/we assume all risks and hazards incidental to such participation including transportation to and from the activities. I/we hereby waive, release, indemnify and agree to hold harmless Conejo Valley Little League, Inc. ("CVLL"), the Board of Directors, organizers, supervisors, participants, volunteers and any other persons involved with Little League activities including transportation, for any claim arising out of an injury to my/our child, whether the result of negligence or for any other cause, except to the extent and the amount covered by liability or accident insurance.

I/we will furnish a certified birth certificate and proof of residence within the CVLL boundary of the player(s) listed on this application to League officials upon request.

Consent for Treatment of a Minor

I/we the parent(s)/guardian(s) of the minor(s) listed on this application, do hereby authorize and consent to any x-ray, examination, anesthetic, medical or surgical diagnosis rendered under the general or specific supervision of any member of the medical staff or emergency department licensed under the provisions of the Medical Practice Act or a dentist licensed under the provision of the Dental Practice Act, and on the staff of any acute general hospital, holding a current license to operate from the State of California Department of Public Health. It is understood that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required but is given to provide authority and power to render care, which the aforementioned physician in the exercise of his/her best judgment may deem advisable. It is understood that effort shall be made to contact the undersigned prior to rendering treatment to the patient, but that any of the above treatment will not be withheld if the undersigned cannot be reached. This authorization is given pursuant to the provisions of Section 25.8 of the Civil Code of California.

Refund Policy

CVLL will refund donations made for all players who register by December 31, 2009, if requests are made by January 14, 2010. No refunds will be made for requests made after this date has passed.

Guarantee to Play Policy

All players who register by December 31, 2009 will be guaranteed a spot to play in CVLL. Placement of players in the various divisions of CVLL is at the sole discretion of CVLL and is based on many considerations including, but not limited to, the player's ability, age, total number of players registering in a given year, equipment or field availability, and other factors that may arise. Players whose registration are received after December 31, 2009 will be given consideration to play based on space available as determined by CVLL.
